  - i. Play to 9 - can play with 8, only 2 players can be assigned to 1 team, no playing in the infield, pitcher or catcher, must bat last. Must go through Player Agent, no self appointing players.
  - ii. D5 Send out reminder email to presidents - send reminder to managers
- e. Interleague
  - i. Reminder to give lineup cards to away teams - should have access to lineups on both sides.
  - ii. May need to purchase lineup cards.
- f. Tournaments - finalize
  - i. *TOC Dates: May 30th - June 6th*
