- a. Feb DA meeting updates
  - i. WR received the OK to remove Liz, nomination emails will be sent out, elections will be held ASAP

**a. Current balance:**

- iii. Player Assessment Fees
  - 1. \$7/kid - suggest raising for 2026 because we would be starting at a zero balance.
  - 2. JR - Not sending blank checks to money from a bank account. Need invoice form actual bank account. OK'd.
  - 3. NO checks will be sent anywhere until bank account is figured out.
    - a. **2025:** some leagues sent money (used for tournaments), some leagues did not. *Those leagues that did not will owe for 2025. Everyone owes for 2026. - discuss further @ next meeting.*
